

# Terms & Conditions

## **Standard Terms and Conditions for the Tero-X Raffle**

### **Qualifying persons,**

The Competitions are open to **ALL** persons aged 18 and over and the age of majority in their country of residence excluding Wild Bike's employees or members of their immediate family, agents, or any other person who is connected with the creation or administration of our Raffle.

### **Promotion Period:**

The Raffle will run for a specified period. Please see each Raffle for details on website for start and end times and dates.

### **Entry:**

You will need to register during your raffle ticket purchase.

These details will be used to contact you if you are a winner so be sure to enter them correctly.

And purchase a ticket, by making an online payment on the website.

### **All Tickets are non-refundable.**

You may enter as many times as you like throughout the Promotion Period providing each entry is accompanied by the new purchase of a ticket.

All entries must be received by the end of the Promotion Period to be valid and no liability is accepted for illegible, incomplete, or late entries.

**Please be aware that some credit card companies consider betting transactions as 'cash' payments, and may charge you a cash advance fee.**

### **The Prize:**

The Prize is one custom Specialized Tero-X e-bike, available in either Medium or Large size.

The bike in question is not brand new. It has been used for a photoshoot and as such has had minimal use, but can be considered "as new".

**Delivery:****Global shipping is offered from South Africa.**

(Any additional VAT/taxes/import duties costs due in the destination/country) will be the responsibility of the Prize Winner.

Delivery of the Prize will be at the Wild Bike Foundation's discretion.

Receivership will be dependent on the date of the winners, confirmation of the size by the winner.

**Winner Selection:**

All valid entries received by The WILD BIKE FOUNDATION during the Promotion Period will moderate all entries.

The moderated entries will then be entered into a draw.

**Winner Notification:**

Winners will be contacted via phone and/or the email address provided upon entry within 14 days of the draw and will be required to respond to confirm eligibility plus acceptance of the prize within 14 days of initial contact.

In the event a winner does not respond to communications within 14 days of initial contact, WILD BIKE FOUNDATION reserves the right to disqualify that winner.

**Moderation:**
